### **Order:-**

In the Government Order first read above, orders have been issued among others, for the formation of Child Welfare Committee in Mayiladuthurai District as per the section 27 (1) of the Juvenile Justice (Care and Protection of Children) Act, 2015.

The Selection Committee after duly following the procedure has sent the list of eligible candidates for appointment of Chairperson and four Members to the Child Welfare Committee in respect of Mayiladuthurai District to the Director of Children Welfare and Special Services. The Director of Children Welfare and Special Services in turn forwarded the same to Government for constituting Child Welfare Committee in Mayiladuthurai District by appointing a Chairperson and four other Members to the Committee in the letter second read above.

3. The Government have examined the proposal and decided to constitute the Child Welfare Committee in Mayiladuthurai District. Accordingly, the following notification will be published in the **Tamil Nadu Government Gazette Extraordinary dated 26<sup>th</sup> March 2025:-**
