### **ORDER:-**

In the Government Order first read above, orders have been issued for reconstituting the Child Welfare Committee in Tiruppur District by appointing a Chairperson and four other Members. The tenure of the Chairperson and four Members of the above Child Welfare Committee ended on 17.09.2023 and the tenure of the committee was lastly extended upto 26.02.2025 in the Government Order third read above.
