ORDER:-

In the Government Order first read above, orders have been issued for the constitution of two additional Child Welfare Committees in Chennai (South Zone) and Chennai (North Zone) by appointing a Chairperson and four other Members. The tenure of the Chairperson and four other Members of the above Child Welfare Committee ended on 15.02.2024 and the tenure of the committee was lastly extended upto 16.02.2025 in the Government Order third read above.

The Selection Committee after duly following the procedure has sent the list of eligible candidates for appointment of Chairperson and four Members to the Child Welfare Committee in respect of Chennai (South Zone) to the Director of Children Welfare and Special Services. The Director of Children Welfare and Special Services in turn has forwarded the same to Government for reconstituting Child Welfare Committee in Chennai (South Zone) by appointing a chairperson and four other Members to the Committee in the letter second read above.
