ORDER:-

In the Government Order first read above, orders have been issued for reconstituting the Child Welfare Committee in Krishnagiri District by appointing a Chairperson and four other Members. The tenure of the Chairperson and four other Members of the above Child Welfare Committee ended on 06.01.2023. The Director of Children Welfare and Special Services entrusted the additional charge of Child Welfare Committee, Krishnagiri to the Child Welfare Committee, Tiruvanamalai District and the above action was ratified by the Government in the Government order second read above.

- 2. The Selection Committee after duly following the procedure has sent the list of eligible candidates for appointment of Chairperson and four Members to the Child Welfare Committee in respect of Krishnagiri District to the Director of Children Welfare and Special Services. The Director of Children Welfare and Special Services in turn forwarded the same to Government for reconstituting Child Welfare Committee in Krishnagiri District by appointing a Chairperson and four other Members to the Committee in the letter third read above.
- 3. The Government have examined the proposal and decided to reconstitute the said Committee. Accordingly, the following notification will be published in the **Tamil Nadu Government Gazette Ordinary dated 27.03.2025:-**
