ORDER:-

The Government first read above, order have been issued for reconstituting the Child Welfare Committee in Thanjavur District by appointing a Chairperson and four other Members. The tenure of the Chairperson and four Members of the above Child Welfare Committee ended on 16.09.2023 and the tenure of the committee was lastly extended upto 16.03.2025 in the Government Order third read above.

- 2. The Selection Committee after duly following the procedure has sent the list of eligible candidates for appointment of Chairperson and four Members to the Child Welfare Committee in respect of Thanjavur District to the Director of Children Welfare and Special Services. The Director of Children Welfare and Special Services in turn forwarded the same to Government for reconstituting Child Welfare Committee in Thanjavur District by appointing a Chairperson and four other Members to the Committee in the letter second read above.
- 3. The Government have examined the proposal and decided to reconstitute the said Committee. Accordingly, the following notification will be published in the **Tamil Nadu Government Gazette Ordinary dated 27.03.2025:-**
