ORDER:-

Based on the announcement made by the Hon'ble former Minister (Social Welfare) for the year 2011-2012, the Government in the Government Order first read above have accorded sanction for a sum of Rs.43.11 lakh [recurring expenditure of Rs.33.26 lakh (consolidated pay and training materials) and non-recurring expenditure of Rs.9.85 lakh (raw material cost)] to impart the training in various modernized vocational trades such as Handyman, Ms-Office, Fast food preparation, Artificial flower making, Cell phone servicing etc., to 2,958 children / women in 8 Observation Homes, 1 Special Home, 1 Children Home, 5 Government Protective / Vigilance Homes and Government After Care Home for Women, Vellore functioning under the control of the Department of Social Defence during the year 2011-2012. The Government is sanctioning funds every year to impart the above scheme to the inmates of various homes functioning under the control of the Department of Social Defence.

2. The Government in the Government Order second read above have accorded sanction for a sum of Rs.14,27,750/- towards recurring expenditure for consolidated pay and training materials to impart training for 6 months in various modernized vocational trades to the expected number of 870 children / women in 11 Government Children Homes, 8 Government Observation Homes, 1 Government Special Home, 1 Government Place of Safety, 3 Government Protective / Vigilance Homes and 1 Government After Care Home for Women, Vellore functioning the control of the Department of Social Defence during the year 2021-2022.

- 3. The Director of Social Defence in her letter third read above has sent proposal for further continuance of the above scheme for the year 2022-2023 and requested the Government to sanction a sum of Rs.14,25,500/-.
- 4. The Government after careful examination, accept the proposal of the Director of Social Defence and accord sanction for a sum of Rs.14,25,500/- (Rupees fourteen lakh twenty five thousand and five hundred only) towards recurring expenditure for consolidated pay and training materials to impart training for 6 months in various modernized vocational trades to the expected number of 1,250 children in 5 Government Children Homes, 9 Government Observation Homes, 1 Government Special Home, 1 Government Place of Safety and 250 women in Government Protective / Vigilance Homes and 1 Government After Care Organization for Women [Vellore] functioning under the control of the Department of Social Defence during the year 2022-2023 as detailed in the annexure to this order.
- 5. The expenditure sanctioned in para-4 above shall be debited under the following head of account:-

Non-Governmental Organizations / Service providers may be identified for every institution by a selection committee to be constituted by the Director of Social Defence. The Director of Social Defence is also permitted to conduct the number of proposed batches of the training even after the completion of the financial year.
