### **ORDER:-**

The Director of Social Defence in the letter read above has stated that children who are more vulnerable, traumatised, lack of care and support, not having scope for opportunities for proper growth and development due to poor family background including street dwellers and experiencing difficulties in everyday livelihood are placed in Government Child Care Institutions by the Child Welfare Committees with a great responsibility of uplifting these downtrodden children as well as those in difficult circumstances. She has also stated that, since there is no modern vocational training programme available for children in Government Child Care Institutions, keeping in mind the revolution in the industrial sector and the growing demand for skilled employees, the Department of Social Defence in collaboration with Tamil Nadu Startup and Innovation Mission (TANSIM) has planned to implement Startup Programmes for children in Government run Child Care Institutions in the State to improve their skills, technical knowledge, stress management and behavior modification, so as to help their overall growth and development.

2. The Director of Social Defence has therefore requested the Government to sanction a sum of Rs.30,00,000/- for implementing the programme in collaboration with Tamil Nadu Startup and Innovation Mission (TANSIM) for welfare and development of children in Government Child Care Institutions through 3 Startups companies in a phased manner.

3. The Government after careful examination of the proposal of the Director of Social Defence, accord sanction for a sum of Rs.30,00,000/- (Rupees thirty lakh only) for implementing the Startup Programme as detailed in the annexure to this order in collaboration with Tamil Nadu Startup and Innovation Mission (TANSIM) for skill development of children in Government Child Care Institutions through 3 Startup companies in a phased manner.



4. The expenditure sanctioned in para 3 above shall be debited to the following new head of account:-

"2235 Social Security and Welfare – 02 Social Welfare 106 – Correctional Services – State's Expenditure KF Skill Development Training to children in the Government child care institutions through startup companies – 372 Training 01 – Training.

IFHRMS (DPC: 2235 02 106 KF 37201)"

5. The expenditure sanctioned in para 3 above shall constitute an item of "New Service" and the approval of the Legislature shall be obtained in due course. Pending approval of the Legislature, the expenditure may initially be met by drawal of an advance from the Contingency Fund. The Director of Social Defence is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Director of Social Defence is also directed to send necessary draft explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2022-2023 to Government in Finance (SW/BG-I) Department at an appropriate time without fail.

6. The Director of Social Defence shall be the Estimating, Reconciling and Controlling Authority of the above new Head of Account. The Pay Accounts Officer / Treasury Officer concerned is requested to open the above new Head of Account in their books.
