#### ORDER:

The Government in Government Orders first, second and third read above have accorded sanction for a sum of Rs.4,79,90,000/- for construction of new building to Annai Sathya Government Children Home, Ramanathapuram, Rs.9,25,00,000/- for construction of new building to Annai Sathya Government Children Home, Pudukkottai and Rs.15,95,00,000/- for construction of new building to Government Place of Safety within the premises of Government After care Organization, Athur, Chengalpattu District.

2. The Ministry of Women and Child Development, Government of India in its letter fourth read above has conveyed the sanction for release of grants-in-aid of Rs.1,21,44,000/- to the Government of Tamil Nadu as first instalment of central share for construction of two new Government run Children Homes at Ramanathapuram and Pudukkottai and Place of Safety at Chengalpattu districts

under the centrally sponsored scheme, namely, "Mission Vatsalya" (Child Protection Services and Child Welfare Services) during the current financial year of 2022-2023.

- 3. The Director of Social Defence in the letter fifth read above has requested the Government to sanction a sum of Rs.202.39 lakh as first instalment towards Central and State share for construction of two Government run Children Homes at Ramanathapuram and Pudukkottai and Place of Safety at Chengalpattu districts under the centrally sponsored scheme, namely, "Mission Vatsalya" (Child Protection Services and Child Welfare Services) during the current financial year of 2022-2023.
- 4. The Government after careful examination of the proposal of the Director of Social Defence, accord sanction for a sum of Rs.1,34,93,000 [Rupees one crore thirty four lakh and ninety three thousand only] towards Central and State share [Central share Rs.80,96,000/- + State share Rs.53,97,000/-] for construction grant to 1 new Place of Safety at Athur, Chengalpattu District under the scheme namely "Mission Vatsalya" (Child Protection Services and Child Welfare Services) in the current financial year of 2022-2023 as detailed below:-
