Order:-

The Government in Government Orders first to third read above have issued orders for constitution/formation of 34 Child Welfare Committees in the then 32 districts.

2. The Government in Government Orders fourth read above have issued orders for creation of new districts namely Kallakurichi, Tenkasi, Chengalpattu,

Tirupathur, and Ranipet. Subsequently, the Government in Government Order fifth read above have also issued orders for creation of new district namely Mayiladuthurai.

- 3. The Commissioner/Director of Social Defence in the letters sixth read above has sent a proposal to Government for formation of 6 Child Welfare Committees in the newly created Districts of Kallakurichi, Tenkasi, Chengalpattu, Tirupathur, Ranipet and Mayiladuthurai at a total cost of Rs.1,35,75,000/- [Recurring Expenditure Rs.1,29,60,000/- (Central Share 35% Rs.45,36,000/- + State Share 65% Rs.84,24,000/-) and Non-recurring Expenditure Rs.6,15,000/- (Central Share 35% Rs.2,15,250/- + State Share 65% Rs.3,99,750/-)] and stated that each Committee may have a maximum of 20 sittings per month as permitted under Child Protection Services Scheme and furnished the expenditure involved for constituting 6 Child Welfare Committees in the newly created Districts which shall be shared between the Central and State in the ratio of 35:65 under the Child Protection Services Scheme.
- 4. The Government of India in its letter seventh read above, among others has released Grants-in-aid of Rs.225.83 lakh towards central share for the component Child Welfare Committees [(recurring grants for 34 existing Child Welfare Committees) and (entire non-recurring grant for 6 new Child Welfare Committees and recurring grants for 6 new Child Welfare Committees for 2 months of Financial Year 2020-2021 with effect from Feb, 2021)] under the scheme of "Child Protection Services" (CPS) for the year 2020-2021. The Government of India in its letter eighth read above among others has also released grants-in-aid of 54.24 lakh towards central share as first instalment for 40 Child Welfare Committees under the scheme namely "Mission Vatsalya" (Child Protection Services and Child Welfare Services) for the current financial year 2021-2022.
- 5. Meanwhile, the Hon'ble Minister for Social Welfare and Women Empowerment Department on 01.09.2021, while moving the demand No.45 of Social Welfare and Women Empowerment Department in the Tamil Nadu Legislative Assembly has made the following as a part of one of the announcements for the year 2021-2022:-

"New Child Welfare Committees will be established by the Government of Tamil Nadu in the new 6 districts namely Tenkasi, Kallakurichi, Mayiladuthurai, Tirupathur, Ranipet and Chengalpattu".

6. After careful examination, the Government accept the proposal of the Commissioner / Director of Social Defence and accord sanction for formation of 6 Child Welfare Committees in the newly created Districts of Kallakurichi, Tenkasi, Chengalpattu, Tirupathur, Ranipet and Mayiladuthurai as per the section 27(1) of the Juvenile Justice (Care and Protection of Children) Act, 2015 as detailed in the annexure to this order at a cost of Rs.1,35,75,000/- [Recurring Expenditure Rs.1,29,60,000/- (Central Share 35% Rs.45,36,000/- + State Share 65% Rs.84,24,000/-) and Non-Recurring Expenditure Rs.6,15,000/- (Central Share 35% Rs.2,15,250/- + State Share 65% Rs.3,99,750/-) and also accord financial sanction for a sum of Rs.70,95,000/- (Rupees seventy lakh and ninety five thousand only) (Central Share 35% Rs.24,83,250/- + State Share 65% Rs.46,11,750/-) for the year 2021-2022 towards non-recurring expenditure in full and recurring expenditure for 6 months [Non-recurring Expenditure - Rs.6,15,000/- (Central Share 35%

Rs.2,15,250/- + State Share 65% Rs.3,99,750/-) and Recurring Expenditure for 6 months - Rs.64,80,000/- (Central Share 35% Rs.22,68,000/- + State Share 65% Rs.42,12,000/-)].
